

Terms and Conditions for Promo Code GENECO80:

1. DEFINITIONS

1.1 "Geneco" means Geneco by Seraya Energy Pte Ltd.

1.2 "Geneco Rebate" refers to

1.2.1 a one-time S\$80 Geneco Rebate applied towards offsetting the Eligible Customer's Geneco electricity bill(s) for the current residential electricity contract they have signed up for with Geneco.

1.3 "Promotion Period" means the period commencing on 30 April 2021 to 31 May 2021, both dates inclusive.

1.4 "Eligible Customer" refers to an individual who:

1.4.1 successfully signs up for a new residential electricity account with Geneco under:

1.4.1.1 any of the following plans (Get It Fixed 24, Get It Fixed 36 or Get Sunny) (the "Eligible Plans");

1.4.1.2 applies the promotion code "GENECO80" at the point of signing up for the relevant plan; and

1.4.1.3 is the registered account holder of the said account;

1.4.2 is not an existing customer of Geneco at the point of signing up for the said residential electricity account;

1.4.3 does not have a Geneco account that was terminated or closed (whether by the individual or by Geneco) in the last twelve (12) months immediately prior to the commencement of the Application Period;

- 1.4.4 is not an existing employee of either Seraya Energy Pte Ltd, YTL PowerSeraya Pte Limited or PetroSeraya Pte Ltd;

- 1.4.1 successfully signs up for a new residential electricity account with Geneco under:
