

Terms and Conditions for Promo Code BDAY53:

1. DEFINITIONS

- 1.1 "Geneco" means Geneco by Seraya Energy Pte Ltd.
- 1.2 "Geneco Rebate" refers to
 - 1.2.1 a one-time S\$53 Geneco Rebate applied towards offsetting the Eligible Customer's Geneco electricity bill(s) for the current residential electricity contract they have signed up for with Geneco.
- 1.3 "Promotion Period" means the period commencing on 22 March 2021 to 30 April 2021, both dates inclusive.
- **1.4** "Eligible Customer" refers to an individual who:
 - 1.4.1 successfully signs up for a new residential electricity account with Geneco under:
 - 1.4.1.1 any of the following plans (Get It Green, Get It Fixed 24, Get It Fixed 36, Get It Less 24 or Get Sunny) (the "Eligible Plans");
 - 1.4.1.2 applies the promotion code "BDAY53" at the point of signing up for the relevant plan; and
 - 1.4.1.3 is the registered account holder of the said account;
 - 1.4.2 is not an existing customer of Geneco at the point of signing up for the said residential electricity account;
 - 1.4.3 does not have a Geneco account that was terminated or closed (whether by the individual or by Geneco) in the last twelve (12) months immediately prior to the commencement of the Application Period;



- 1.4.4 is not an existing employee of either Seraya Energy Pte Ltd, YTL PowerSeraya Pte Limited or PetroSeraya Pte Ltd;
- 1.4.5 is not an immediate family member of the persons referred to in Clause 1.4.4 above, including spouse, children, siblings and parents; and
- 1.4.6 is not a person deemed ineligible and/or notified by Geneco as being ineligible from time to time.

1.5 "Award" refers to

1.5.1 a one-off rebate with a value of S\$53 which shall be credited to the Eligible Customer's Geneco residential electricity account which may be used to offset their Geneco electricity bill(s) before GST.

2. PROMOTION ELIGIBILITY REQUIREMENTS

- 2.1 An Eligible Customer is deemed to have successfully signed up for a new account with Geneco if all the following conditions are met:
 - 2.1.1 The Eligible Customer submits an application for any one of the Eligible Plans during the Promotion Period, available at https://www.geneco.sg/residential/electricity-plans/, during the Promotion Period.
 - 2.1.2 The Eligible Customer successfully applies either the promotion code "BDAY53" at the point of signing up for any of the following plans (Get It Green, Get It Fixed 24, Get It Fixed 35, Get It Less 24 or Get Sunny).
 - 2.1.3 The Eligible Customer satisfies all of the conditions as stated at Clause 1.4 hereinabove.
 - 2.1.4 Such application is approved by Geneco within two (2) to four (4) weeks from the application submission date.



- 2.2 Upon full satisfaction of the conditions stated at Clause 2.1 hereinabove, the Eligible Customer will be deemed eligible for the Award.
- 2.3 For the avoidance of doubt, this promotion is not applicable to any sign-ups under Geneco's Give Us A Try plan, details of which are available at https://www.geneco.sq/residential/electricity-plans/.

3. GENERAL TERMS AND CONDITIONS

- 3.1 The "BDAY53" promotion code is valid and limited to the first 1,000 Eligible Customers who successfully sign up for any of the following plans (Get It Green, Get It Fixed 24, Get It Fixed 36, Get It Less 24 or Get Sunny) during the Promotion Period.
- 3.2 Eligible Customers who fulfil the conditions set out in Clause 2.1 above will receive their Award in the form of one-off rebate with a value of S\$53 which shall be credited to the Eligible Customer's Geneco residential electricity account and may be applied to the reduction of the Eligible Customer's Geneco electricity bill(s), within 60 days from the date on which their application is approved. The Award shall not apply if the Geneco account is closed on or before the date that the Award is awarded by Geneco.

 - 1.2.2 S\$20 worth of grocery vouchers to be determined by Geneco.
- 1.3 "Promotion Period" means the period commencing on 22 March 2021 to 30 April 2021, both dates inclusive.
- 1.4 "Eligible Customer" refers to an individual who:



- 1.4.1 successfully signs up for a new residential electricity account with Geneco under:
 - 1.4.1.1 the following plan (Get It Fixed 24) (the "Eligible Plan");
 - 1.4.1.2 applies the promotion code "BDAY73" at the point of signing up for the relevant plan; and
 - 1.4.1.3 is the registered account holder of the said account;
- 1.4.2 is an existing customer buying electricity from SP Group but switching to Geneco at the point of signing up for the said residential electricity account;
- 1.4.3 is not an existing customer of Geneco at the point of signing up for the said residential electricity account;
- 1.4.4 does not have a Geneco account that was terminated or closed (whether by the individual or by Geneco) in the last twelve (12) months immediately prior to the commencement of the Application Period;
- 1.4.5 is not an existing employee of either Seraya Energy Pte Ltd, YTL PowerSeraya Pte Limited or PetroSeraya Pte Ltd;
- 1.4.6 is not an immediate family member of the persons referred to in Clause 1.4.4 above, including spouse, children, siblings and parents; and
- 1.4.7 is not a person deemed ineligible and/or notified by Geneco as being ineligible from time to time.

1.5 "Award" refers to

- 1.5.1 a one-off rebate with a value of S\$53 which shall be credited to the Eligible Customer's Geneco residential electricity account which may be used to offset their Geneco electricity bill(s) before GST; and
- 1.5.2 S\$20 worth of grocery vouchers to be determined by Geneco.

 - 2.1.2 The Eligible Customer successfully applies either the promotion code "BDAY73" at the point of signing up for the following plan (Get It Fixed 24).

 - 2.1.4 Such application is approved by Geneco within two (2) to four (4) weeks from the application submission date.

the Eligible Customer's Geneco electricity bill(s), within 60 days from the date on which their application is approved. The Award shall not apply if the Geneco account is closed on or before the date that the Award is awarded by Geneco.
