

## 1 Year Free Electricity Giveaway 2026 (“Contest”) Terms & Conditions

### A. *Official Contest Rules*

1. The Geneco Lucky Draw Contest (the “**Contest**”) is organised by Geneco (“**Geneco**”) by Seraya Energy, a subsidiary of YTL PowerSeraya Pte Limited (the “**Organiser**”). Participants should note that the terms “Geneco” and “Organiser” will be used interchangeably in the course of this Contest and shall be taken to have the one and the same meaning.
2. The Organiser reserves the right to change any terms and conditions of the Contest at its sole and absolute discretion, without prior notice, reason or liability. By entering the Contest, the Participants not only undertake to review the Terms and Conditions of the Contest at any particular time, which has been made available for public viewing at the Contest page [www.geneco.sg/power-savings](http://www.geneco.sg/power-savings) but also agree to be bound to subsequent new or amended Terms and Conditions (if any).
3. The Organiser also reserves the right to terminate, cancel, suspend or amend (including but not limited to replacing the Contest’s prize with one or more items of similar value) the Contest at any time without prior notice, reason or liability. The Organiser accepts no responsibility and/or liability for any deviation in the prize values (if any).

### B. *Eligibility Conditions*

4. Subject to the provisions of these Terms and Conditions, this Contest is only open to participants who satisfy the following conditions within the Contest Period:
  - (a) Currently reside in Singapore at a permanent residential address (the “**Residential Address**”) and is the registered account holder (or the authorised person) of the Residential Address;
  - (b) Have a Get It Fixed 24 residential electricity account with Geneco;
  - (c) Such application under Clause 4(b) is approved by Geneco and the contract is activated by 30 November 2026;
  - (d) Have a Geneco account with a valid residential electricity contract of at least 12 months from 30 November 2026;
5. Notwithstanding the foregoing, employees of the Organiser, YTL PowerSeraya Pte Limited, or PetroSeraya Pte Ltd and their immediate family members (such as their spouse, children, siblings, and parents) are not eligible to participate in the Lucky Draw. The Lucky Draw is also not open to any other participant deemed ineligible and/or notified by the Organiser as being ineligible at any point during the course of the Lucky Draw.

### C. *Contest Period*

6. The Contest period shall begin on 30 June 2026 at 12:00pm and end on 31 August 2026 at 11:59pm (the “**Contest Period**”). The Organiser reserves their right to amend the Contest Period at any time without prior notice.

**D. Selection of Winners, Prizes and Notifications**

7. There will be a total of five (5) winners selected at random by the Organiser for this Contest. Each eligible participant on a Get It Fixed 24 plan will receive one (1) chance to enter the Lucky Draw.
8. Each winner will be entitled to one (1) year’s worth of free electricity worth S\$1,650.00 (“**Prize**”). The rebate of S\$1,650.00 (the “**Bill Rebate**”) shall be credited to the respective winner’s Geneco residential electricity account to offset the winner’s Geneco electricity bill (“**Electricity Bill**”). If the Electricity Bill amounts to less than the value of the Bill Rebate, the remaining value will be used to offset the subsequent Electricity Bill(s). For the avoidance of doubt, the Bill Rebate shall only be used to offset Electricity Bill(s) and not be used to offset any security deposit or non-electricity usage related charges under the winner’s Geneco account.
9. Each winner must maintain an active eligible Geneco residential electricity account throughout the Prize Period. Any unused portion of the Bill Rebate shall be forfeited if the winner’s eligible Geneco residential electricity account is terminated, closed, transferred, or expires before the full Bill Rebate has been fully credited. No refund, cash equivalent, or replacement shall be provided for any forfeited portion of the Bill Rebate.
10. The Prizes are non-transferable and cannot be exchanged for cash, any other forms of credit, and/or any other goods or services, and is subject to such other terms and conditions as may be imposed by the Organiser.
11. The results of the Contest shall be final and binding, and no appeal against the Contest’s results shall be entertained. In the event of any dispute, the Organiser’s decision shall be final and no further correspondence will be entertained.
12. The Organiser shall announce the winners of the Contest by 31 December 2026 via Electronic Direct Mailer (“**eDM**”) to the winner’s email address registered under the winner’s Geneco account with methods for the Prize redemption. The winners must follow the redemption process provided in the eDM to redeem the Prize. Failure of the winner in complying with the redemption process may result in a delay in the receipt and/or disbursement of the Prize to the winner’s Geneco residential electricity account.
13. The winner must redeem the Prize within 30 calendar days from the date of receipt of the eDM (“**Redemption Period**”). Failure of the winner to redeem the Prize within the Redemption Period will render the Prize as forfeited and unaccepted. The Organiser will not be responsible and/or will not entertain any request or appeal for the failure of any winner to redeem their Prize within the Redemption Period.

**E. Disclaimer**

14. Should any of the Terms and Conditions stated herein be held illegal or unenforceable, such term or provision shall be deemed to be deleted from the Terms and Conditions of the Contest. The rest of the Terms and Conditions shall remain in full force and effect. Failure by the Organiser to exercise any of its rights as stated in the Terms and Conditions herein does not and should not constitute a waiver of those rights.
15. Should there be any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with this Contest, these Terms and Conditions shall prevail.

***F. Use of information and publicity***

16. Participants are deemed to have provided consent to the Organiser and its affiliates, pursuant to the Personal Data Protection Act 2012, for the collection, storage, use and disclosure of their personal data for the purposes of administering and accessing this Contest.
17. By participating in this lucky draw, you further consent to the collection and use of your name and email address for the purpose of receiving marketing emails about the latest promotions, rewards, and news from Geneco.

***G. Limitations and Indemnity***

18. Participants shall assume all risk in respect of loss, injury, damage or liability which may arise as a result of or in connection with the participant's participation in the Contest.

***H. Governing Law and Jurisdiction***

19. The Contest and the Terms and Conditions associated therewith shall be governed by Singapore law. By participating in the Contest, each participant agrees to submit to the exclusive jurisdiction of the courts of the Republic of Singapore insofar as the subject relates to the Contest and Terms and Conditions associated therewith.
20. For the avoidance of doubt, a person who is not a party to any agreement governed by these Terms and Conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any terms of such agreement.
