<u>TERMS AND CONDITIONS GOVERNING UNITED OVERSEAS BANK LIMITED ("UOB") CREDIT AND DEBIT CARDS</u> <u>S\$20 BILL REBATE – GENECO ELECTRICITY BILL PAYMENT PROMOTION ("PROMOTION")</u>
